PANEL SPEAKERS



Azadeh Tamjeedi is the Acting Senior Legal Officer at UNHCR, the UN Refugee Agency, in Canada. She has worked with UNHCR since 2017 and is currently based in Ottawa. During her time with UNHCR she also worked at the office in Vancouver for two years. In 2018, Azadeh completed an emergency deployment to Boa Vista, Brazil to assist with the large number of Venezuelans arriving in the country. Prior to working with UNHCR, Azadeh worked as a lawyer at the Centre Francophone de Toronto where she represented asylum-seekers before the Immigration and Refugee Board of Canada (IRB) and the Federal Court of Canada. As

a law student, she specialized in social justice issues and gained valuable advocacy experience at the Parkdale Legal Clinic in the area of poverty law. She holds a Bachelor's degree in Honours History and Political Science from McGill University and a Juris Doctorate degree from Osgoode Hall Law School, York University. Azadeh was called to the Ontario bar in 2011.



Hannah Scott is the Social Media and Digital Content Associate at UNHCR, the United Nations Refugee Agency in Canada. At the organization, she manages UNHCR Canada's social media channels, website, and other digital fundraising platforms while telling the stories of refugees worldwide. As an alumni of the Communications and Digital Media Studies program at the University of Ontario Institute of Technology, she is intrigued by the ways that communication technologies can alter the existence and consequences of humanitarian issues such as the refugee crisis. A

graduate of the Masters of Social Justice and Community Engagement program at Wilfrid Laurier University, Hannah has studied and reported on refugee issues in the past, writing her thesis on the coverage of refugees in Canada's legacy print news organization. Presenting on refugee issues such as the Rohingya crisis at conferences such as the National Communications Association Conference in Salt Lake City, Utah, Hannah is inspired to stand alongside refugees to tell their stories to Canadians and individuals worldwide so they can understand their plight.



Shaza AlShamsi (she/her) is a 22-year-old Syrian student at the University of British Columbia in Vancouver, B.C., Canada, who is interested in pursuing a Behavioral Neuroscience major. Shaza is from a small town in Syria, where she lived until she was 14 years old. She and her family moved to Lebanon in 2012, where she stayed for about six years before moving to Canada. Her family is still located in Lebanon. When Shaza was 16, she moved back to Syria alone, determined to pursue her studies. She received her grade 9 degree and studied for

grade 10 during the summer break at home. When school started again, she was able to enroll in eleventh grade, which she passed before working on her grade 12 degree. From living in the war to moving around the world alone, Shaza has faced many difficulties along the way, namely homesickness. However, she was willing to put all her attention on her studies, her dream, and her mission. Shaza cannot wait to join VYMUN 2020 and share the story of her journey to Canada and where she is now. She hopes everyone stays healthy and enjoys the conference!

KIVA AT VYMUN

Kiva is a non-profit aid organization that “creates opportunity and alleviates poverty.” It provides micro-loans to individuals so that they can become entrepreneurs, businessmen and women and leaders within their own communities. Every day, Kiva matches borrowers with partner institutions. All Kiva loans are made possible by Field Partners, who vet, administer, and disburse each loan. Each loan recipient presents a profile of the nature of their loan request.

For example, “A 28-year-old woman, Rahamatou is single and does not have any children under her care. She has been selling general food products in a local market since 2005. She has a keen ear for business and knows that by expanding her business of buying and selling products she can make a profit. Her loan, for example, will be paid back to donors within 14 months. Rahamatou, from Togo received her loan of \$1400 to kick-start her business and change her life. She wants to earn enough money to be independent and then have a family.”

Loans are often significantly smaller, ranging from a few hundred dollars to loans comparable to that of Rahamatou. On any given week, 5,859 borrowers will receive their loan. As a result of its impact in the field of microfinance, Kiva has been awarded Charity Navigator’s highest rating. Kiva provides a platform for those who want to make a difference in their own lives and their families and communities.

VYMUN is proud to continue the tradition of donating a portion of the delegate registration fee to KIVA.

VYMUN 2020 will run as a virtual conference this year.

Subsequently, our opening ceremony, closing ceremony, and committees program will be hosted on the video conferencing platform “Zoom.” We encourage delegates to explore Zoom prior to the conference weekend to better familiarize themselves with the platform. Although VYMUN will be conducted in an online format, all delegates and attendees are expected to demonstrate respect for their self, peers, staff members, and any adults. All attendees must be dressed in Western Business attire. Delegates will interact with one another and use technology responsibly and for productive means only; as such, all participants will refrain from harassment and model appropriate behaviour at all times. Unacceptable delegate behavior includes, but is not limited to: bullying, threats, harassment, discrimination, racism, sharing of hate speech, plagiarism, use of drugs, alcohol, cigarettes, vaping and vaping apparatus. Should delegates exhibit disrespectful or unacceptable behaviour, their sponsor teacher or head delegate will be contacted, and the delegate may be promptly removed from committee session.

Though Rules of Procedure and proper Zoom etiquette will be covered in the first committee session, we encourage delegates to attend our optional MUN workshop (October 30 6:00-6:30pm PST) to learn more about Model UN and the Zoom platform.

COMMITTEE OVERVIEWS

ECOFIN

The second of six general assemblies, the Economic and Financial Committee acts as a forum for member states to discuss global financial and economic matters. Since its inception in 1945, ECOFIN has strived to uphold its mandate and values. Whether its domestic or international policy, ECOFIN's mandate spans 11 different themes covering issues ranging from the eradication of poverty to financing for development. With the uncertain future of the global economy, ECOFIN will play a pivotal role in the economic recovery for years to come.

WHO

Since its establishment in 1948, the World Health Organization (WHO) has been working with 193 member states to bring awareness to causes of pressing health issues and to fight communicable diseases. WHO strives to fulfill its objectives through the six point agenda: (1) promoting development; (2) fostering health security; (3) strengthening health systems; (4) harnessing research, information and evidence; (5) enhancing partnerships; and (6) improving performance.

UNHCR

The United Nations High Commissioner for Refugees (UNHCR) is devoted to protecting refugees, internally displaced communities, and stateless people worldwide through assisting their repatriation and resettlement to new countries. With the current global conflicts, there has been an increase in the number of people forcibly displaced from their homes, and as a result, the organization has been brought to the spotlight and scrutinized for its ability to coordinate international action.



COMMITTEE OVERVIEWS

EU

The European Union was created in 1993 to both politically and economically unify a number of European countries. Currently, it is composed of 28 nations. The EU was created in response to the devastation of World War II in hopes of preventing the violence and oppression that occurred during the war from happening again. Essentially, it is a union that was created to establish and maintain peace. However, as the years pass, challenges have arisen within the EU. These difficulties include issues such as the European Immigration Crisis, and the upcoming separatism of the United Kingdom from the EU.

UNEP

The United Nations Environment Programme (UNEP), founded in 1972, is the leading international body responsible for promoting environmental action. Headquartered in Nairobi, Kenya, its mission is to encourage cooperation in preserving the environment and to assist developing countries in creating environmentally sound practices. Some of its focus areas are sustainable agriculture, climate change, natural disaster aversion, waste management, and environmental governance. With the ticking clock of climate change, UNEP is becoming one of the most critical and urgent forces in the world to minimize our carbon footprint and ensure a safe future.

ASEAN

Formed in 1967, ASEAN, or The Association of Southeast Asian Nations, aims to accelerate economic growth, promote regional peace and stability, and provide assistance among member states, alongside other developmental goals. The ten-member states work closely together to further the progress of the Southeast Asian region and maintain a presence in the international league. From economic crises to judicial systems, ASEAN covers a broad range of issues that arise in the Indo-Pacific Ocean.

NATO

Established in 1949 in response to a growing Soviet threat, the North Atlantic Treaty Organization (NATO) is a military alliance between 29 North American and European countries. In recent years, NATO has taken more of a peacekeeping role, participating in operations in Kosovo, Afghanistan, Iraq, and Libya. The United States, NATO's largest military contributor, has grown skeptical of the organization, rendering its future and importance to international politics unclear.



COMMITTEE OVERVIEWS

UNSC

Founded in 1945, the United Nations Security Council is primary responsible for the maintenance of international peace and security. It has ten rotating members, and five permanent members with veto power. UNSC determines the existence of a threat to the peace or act of aggression and calls upon its members to settle it by peaceful means and recommends methods of adjustment or terms of settlement

HCC

The Historical Crisis Committee (HCC) is a continuous crisis committee which distinguishes itself from the general and specialized committees. The committee makes decisions that immediately affect the historical crisis at hand. Although delegates know how the crisis ended in the past, they are encouraged to imagine themselves in the shoes of the historical figures that impacted these events and change history, for better or worse. Delegates must be able to balance their personal interests with the interests of their respective characters.

ACC

The year is 1193, the end of the 3rd Crusade. After nearly half a decade of conflict and battle, powerful leaders and Kings have gathered in the neutral territories of Constantinople to decide the fate of the Eastern Mediterranean and the many Kingdoms, Duchies, and City-States within the region. Empires and Kingdoms are divided on matters of land distribution, religious freedoms, and political control. Delegates in this committee are tasked to find a diplomatic solution to these negotiations or else descend into war and chaos.

Cabinet

The year is 1642, and the tyranny of English King Charles I is rampant. After attempts to arrest perceived Puritan sympathisers within parliament, the King's power has increasingly become threatened by the radical Oliver Cromwell and his republican tendencies. At this point in time, England is divided between Protestants and Catholics, but is more importantly divided on matters of democracy, monarchy, and ultimately, the role that the state ought to play in citizens' lives. Delegates will have to unravel the unique sociocultural tension of 17th century England while attempting to hold on to political and military power. Whether it collapses into conflict or is able to reconcile its differences to move forward into a more pluralistic society, England will never be the same.
